



## Jason James Gibson

May 5, 1983 - September 9, 2016

Jason James Gibson, age 33, passed away at his residence in Madison Heights on September 9, 2016. He was born in Royal Oak and was a Covenant member of Woodlawn Church, as well as a strong advocate for Warrior's Hope Ministry, a Christ-centered ministry for combat veterans suffering from PTSD. Jason also served in the U.S. Army as a member of the 10th Mountain Division at Ft. Drum, New York. His hobbies included camping, fishing, and do-it-yourself projects, and he loved horses, country music, and big belt buckles.

Jason is survived by his spouse, Brittany N. (Lincoln), married November 15, 2014 in Grand Blanc; and his children, Carrie-Ann Gibson (and her mother Danielle Gibson), Logan James Gibson, and Gabriel Paul Gibson. He was predeceased by his daughter, Adeline N. Gibson, on January 23, 2014. Jason is further survived by his parents, Larry and Sally Gibson; mother-in-law, Amy M. Lincoln; father-in-law, James W. Lincoln; brother, Brian (Cara) Gibson; brother-in-law, Brandon A. Lincoln; nephew, Connor Gibson; niece, Alexandra Gibson; and many loving aunts, uncles, and cousins.
