“As we prepare to say goodbye to you tomorrow, I have to say some words now, because I am not sure I am strong enough to say them tomorrow.

*“My sweet sister... (MeSister) you are thirteen years younger than me, but in so many ways you carried a strength and grace far beyond your years. We walked the same “cancer path” that no sisters should ever have to share.*

On the day before Thanksgiving we talked about now setting the goal now to Christmas. The day after Thanksgiving you sent Trayten and Irelynn on a treasure hunt in your rooms upstairs to find some Christmas items to start the decorating for Christmas. Little did anyone know that they next day you would leave us, short of your next goal. Losing you at 58 feels unbearably unfair. It feels like the world should have given you more—more time, more joy, more life.*

*But I am grateful for the years we had. Grateful for your laughter, your kindness, your stubborn strength, and the bond only sisters can understand. I will miss you every single day, but I will also carry you with me—in my heart, in my memories, in the parts of me shaped by being your big sister.*

*You were wearing a sweatshirt one day that read "Do What Makes You Happy" - that is now my new motto.*

*Goodbye, my beautiful sister. I hope you're at peace now, free from pain and holding your son that was also taken way to soon. And I hope you know how deeply you were loved."*
